Message from the Executive Director

20 years of impact

This year has been marked by many successes and achievements, reflecting well the 20 years of the *Réseaux de santé*'s commitment to the Francophone community in Northern Ontario. Our theme for this year, "The *Réseau*, Catalyst of the Health Care System for Francophones" is very relevant, as it highlights the Réseau's active role in planning health care services for Francophones at many levels of the health care system. This theme underlines the impact of the Réseau on positive changes in access to equitable health services, in French, for Francophones.

At the local and regional health system level, we optimized our collaboration with Ontario Health North, and developed strategies for French-language services to support Ontario Health Teams (OHTs) in their efforts to meet the needs of Francophones. We also continued to support health service providers in their offer of French-language services through the Active Offer training, which continues to be recognized and used across the province - and even the country!

At the provincial level, we have also offered several recommendations to Ontario Health (with a particular focus on their business plan), and to the Ministry of Health regarding the importance of access to French-language health services, care planning, reporting on French-language services, the evaluation of Ontario's French-language health services planning model, and finally to the government regarding new regulations. We also continue to collaborate with many provincial organizations, including the Assemblée de la francophonie de l'Ontario (AFO) and its health committee, to develop positioning documents on health priorities for Francophones. At the national level, the Réseau also contributed to the Société Santé en français' 2023-2028 programming and call for project proposals, and continued to act as a resource for Active Offer training. At the community level, we adapted our interactions to strengthen trust and collaboration in Francophone communities through new initiatives. We are proud of the role we play in the healthcare system, and we remain committed to continuing to positively influence access to French-language healthcare services for Francophones in Ontario. I would like to extend my warmest thanks to the members of the Board of Directors, and especially to our Chair, Mr. Collin Bourgeois, who has completed his mandate after nine years with the Réseau. I would also like to thank our dedicated team, our partners and our members for their ongoing commitment and support. It is thanks to your collaboration that we are able to achieve our mission and make a real difference.

Evaluating the impact of our work


Our ongoing efforts to foster a culture of improving French-language health services that are better adapted to the needs of the Francophone community are demonstrated through our efforts to evaluate of our work. We have undertaken a collaboration with the **Centre for Rural and Northern Health Research** (CRaNHR) to assess the impact of the Active Offer training on the behaviour of people who took the training. The data collection process began last year. To date, 7,000 participants have completed the pre-training questionnaire and since December 2023, 416 the post-training questionnaire have been completed. This collection will continue until May 2025.

In addition to the evaluation project, we gathered information on participants' satisfaction with the Active Offer training. We are proud to say that 96.4% are satisfied or very satisfied with the training.

The Importance of Francophone patient stories

Through its various commitments and projects over the years, the *Réseau* has gathered testimonials on the experiences of Francophone clients and patients with French-language healthcare services in Northern Ontario. We targeted 52 testimonials to highlight the challenges faced by Francophones when seeking healthcare in their mother tongue.

While many factors can influence the patient experience, access, equity and quality of services in French were identified as priority issues by those who shared their stories. These elements were highlighted in a summary report prepared to support our planning work by demonstrating the reality of francophones who use healthcare services in Northern Ontario.




Advising and Supporting the System

Recommendations for strengthening the French-language health care system

This year, 34 recommendations were shared with provincial and regional government bodies to provide a clear roadmap for necessary changes based on a thorough understanding of the needs and challenges specific to Francophones.

Our interventions enabled:

- the enhancement of the platform created for annual reports of Frenchlanguage services that are required by providers
- the initiation of the legal process for updates required in the *French language* services Act for certain providers who have changed status or name
- the updating or inclusion of policies by providers to ensure the Active Offer of French-language services in order to ensure compliance to their designation status
- a collaborative approach with Ontario Health North to capture data on Francophones
- a continuation of the joint work plan between the *Réseau* and Ontario Health North



French-Language Services Annual Reports

Each year, health service providers are required to complete a French-language services report. Thanks to the support of the Réseau, 99% of providers have submitted their annual French-language services report for 2023-2024.



Advising and Supporting the System

An inclusive engagement strategy

The face of the Francophone population is changing, and so we need to change the way we engage Francophones to reduce disparities and promote equity and inclusiveness.

It was therefore important for the Réseau to work closely with francophone minority groups to ensure that everyone's voice is heard.

The question of the Month

Our engagements this year

- As part of the Immigration project, the Réseau continued to work with local settlement services to ensure that all francophones are heard.
- The Réseau continues to work with the carrefours and health tables to keep the community's pulse.
- Participation in the Resolutions 2023: Overcoming Racism Together conference.
- The entire team participated in a six-session training offered by Ontario Health on equity and inclusion. This training enabled us to inform them on how to ensure greater inclusion of Francophones in their training, which is intended for all their employees.

Listening to Francophones in the North

The Question of the Month is a new engagement initiative that saw its debut in February 2024. We launch one question per month to gather information on the reality of Francophones. The results of these questions help us direct our work toward the topics that matter in health for the region's Francophones. Topics addressed to date include: access to primary care, interpretation services, patient and family counsels, and mental health.

Support work that has an impact on the system

Every three years, designated health service providers are evaluated by the Réseau and Ontario Health North to determine whether they meet the requirements for designation under the *French Language Services Act*. This year, 17 evaluations were completed. Of the 17 assessments, 10 providers complied with 100% of the requirements. Congratulations to the compliant providers for their dedication to maintaining the French-language service requirements. We continue to support the remaining seven providers so that they can be compliant with the necessary requirements in the coming year.

New developments for the training

Improvements have been made to the Active Offer training platform to facilitate group and participant registration, as well as data extraction.

We have also added two new complementary modules:

<u>Services Adapted to Francophone Clients in the Mental Health and Addictions Sector</u> and <u>Francophone</u>

<u>Cultural Awareness in the Primary Care Sector</u>.

Certificates awarded this year



Staff awareness

Following our partnership with <u>Home and</u>

<u>Community Support Services</u>, the organization has implemented a policy that all employees (9 000) must complete the Active Offer training. We worked with the 14 regional offices to register and send out reminders as well as produce completion status reports for managers in each region.

The list of providers who have completed the training is growing. This year, five healthcare organizations received certificates of training completion when 100% of their teams completed the training. The growing list now includes 17 providers.

In addition, the <u>NOSM University</u> has made the complementary primary care module mandatory for all residents in their program. This measure ensures ongoing awareness among our future physicians.



Developing, Managing and Assessing Progress

Franco-Santé Project

The Franco-Santé project is an initiative for the Francophone and Francophile student population enrolled in post-secondary health training programs in English. At the national level, a study was conducted to develop a national outreach strategy to engage faculties and programs. The Réseau contributed to the process by providing comments and recommendations on the strategy during discussions at the national table. We also shared issues and best practices with other Réseaux to ensure the sharing of expertise, tools and resources. As part of the project's programming, the Réseau organized a training session on services adapted to Francophone clients in the mental health and addiction sector.

Healthy Early Years Project

Although the Réseau is responsible for the project in Ontario, the work in the field is carried out by two promoters, <u>Health Nexus</u> and the <u>Association Francophone à</u> <u>l'éducation des services à l'enfance de l'Ontario</u> (AFÉSEO). This year marks the end of a five-year funding period and the beginning of a new funding cycle for the project.

This year, our partners have, among other things:

- set up an advisory committee of professionals and parents;
- set up a Facebook group, *Parenthèse Ontario: Informations et ressources en petite enfance*;
- published 11 resource podcasts featuring parent testimonials;
- delivered four webinars on mental health promotion and Francophone living practices;
- facilitated five support groups;
- delivered two webinars and created two autism resources.

Developing, Managing and Assessing Progress



Francophone Immigration Health Project

The Francophone Immigration Health project is led by the Réseau franco santé du Sud de l'Ontario (RFSSO) in Ontario in collaboration with the Réseau du mieux-être francophone du Nord de l'Ontario (RMEFNO) and the Réseau des services de santé en français de l'Est de l'Ontario (RSSFE). As part of this year's project, the RFSSO has developed the training module: Connaître le système de santé de l'Ontario et comprendre comment s'y retrouver. It is available on the eQUITY Link platform. For its part, RMEFNO has developed a Virtual Resource Kit for Improving Health Services for Francophone Immigrants in Ontario as part of the project to follow up on the training Active Offer of French Language Health Services to Francophone Immigrants in Ontario.

Long-term care

Following discussions with caregivers in the community about the Active Offer training complementary module on Culturally Appropriate Care for Francophones in Long-term Care Homes and the accompanying tools and resources kit, it was identified that a specific resource for family caregivers should be created to facilitate navigation between the homecare and long-term care systems, as well as available resources. The result was a resource kit for caregivers of Francophones in long-term care.

Strategically Coordinating Engagement and Mobilization

Ontario Health Teams

Ontario Health Teams (OHTs) are a new, more patient-focused way of organizing and delivering care in their local communities. Northern Ontario has eleven OHTs, including two accelerated OHTs, Nipissing Wellness and Noojmawing Sookatagaing.

How we support OHTs

The Réseau continues to support the OHTs in building capacity for French-language services and ensuring equitable access.

We provided recommendations on what to include in the French services section of the work plan for the two accelerated OHTs. These recommendations were also shared with other OHTs to inform their French-language services work plans. The Réseau is also an active member of the OHTs equity committees as an advisor on French-language services, and we have helped then engage the Francophone community to include the Francophone perspective in the deployment of OHT activities.



Strategically Coordinating Engagement and Mobilization



The Réseau launched the Winning Strategies initiative in Northern Ontario with the goal of helping all health service providers improve the quality of and access to French-language health services. We received support from five OHTs to implement the initiative, as well as from Ontario Health North.

In collaboration with <u>Nipissing Wellness</u> OHT, the initiative was officially launched in Northern Ontario.

This initiative was created by the <u>Kids Come First</u> OHT and the <u>RSSFE</u>. To date, 14 OHTs in the East and the North have committed to participate in the initiative.

A glimpse

The strategy aims to unite OHT members and partners around six actions promoting active offer:

- 1. Identify one or more champions
- 2. Empower staff members
- 3. Identify staff members able to provide services in French
- 4. Identify Francophone clients
- 5. Match Francophone clients with staff able to provide services in French, or refer Francophone clients to another provider offering equivalent services of equal quality in French.
- 6. Measure results

- Participation in the provincial French-language services committee of Home and Community Care Services.


